## **April 8, 2024**

The April 8, 2024 meeting of the Berks County Industrial Development Authority was held off-site and called to order at 8:33 AM by the Chairman, Mr. Jenkins.

The meeting was paused to hold the Berks County Industrial Development Foundation meeting at 9:00 AM.

The Board reconvened the regular Authority meeting at 9:05 AM.
